Dear Sir/Madam

I am to say that Akhil Bharatiya Gondwana Gond Mahasabha is working in  
Odisha since 2015 for all-round development of Gond Samaj in particular and

others in general. In the mean time two different Maha Adhibesan and several cultural, leadership development etc programmes have been organized. It has been an witness that more than three lackh delegates had participated in each Adhibesan. Both Adhibesan have been organized smoothly and so many decisions have been taken to gear up the development of samaj. I congratulate you for your kind cooperation for such grand success. But you have been remembered that the final and complete accounts of the Mahasabha for the year 2017 - 18 have not been submitted to state committee till date. In the mean time a case has been filled before Hon'ble High Court Odisha Cuttack by Sri Jagdish Dhurua and others vrs State of Odisha and others in W.P (c) No. 102/2018 (copy enclosed). The following allegations have been raised in the petitions.

Para – 6

That Op No – 5 and 6 have are using different names of different organization making them as president and secretary of so called Organization. Like on of such organization is Akhil Bharatiya Gondwana Gond Mahasabha. They are making such type of Sabha in order in make themselves unjust enrichment by collecting money from poor persons and spending them lavishly their own luxury and interest. They had arranged the aforesaid Mahasabha and spread leaflet for the same in different village in the community

The copy of the Mahasabha held in 23.12.2016 to 26.12.2016 is annexed as Annexure -4

PARA - 7

That OP No – 5 and 6 with the help of 7 to 12 having been collecting money forcibly since last several years by extortion giving threat of expulsion and punishment. They are giving receipt as per their own accord. If anybody asked about the same he is reprimanded and assaulted by them. So innocent persons paying them with the fear of ostracizing and out casting of there family. In such manner huge amount is collected by OP No – 5 and 6. In the name Mahasabha they are collecting amount and without any account they are spending as per their own whim for their personal interest.

The copies of receipts showing collections are annexed as Annexure – 5

#### PARA - 8

That, when these petitioners and other asked for account of the amount collected they are threatened and out-casted by them. They also spreading an anti-wave against these petitioners making false allegations and defaming families of these petitioners and other supporters of these petitioners. So these petitioners and others filed F. I. R against them before the IIC, Loisingha Police Station on 01. 02 . 2016 and sought for stringent action against them. In the FIR it is mentioned that, OP parties No 4 to 6 collected amount putting them in threat which amounts extortion and illegal act of the OP No - 5 and 6. But till date no action is taken against them.

The copy of FIR dated 01. 02. 2016 is annexed as Annexure - 6

#### PARA - 9

That when no action was taken OP No - 4 to 12, they became arrogant and dictator in their attitude. They collected amount with threat and misappropriated such amount without any fear of law. When these petitioners asked about the same they threatened these petitioners with dire consequence for which these petitioners and other against lodged F.I.R against them in the Loisinga police station which was received by the IIC loisinga on 20.11.2017 giving his endorsement. But till dated no action is taken against them.

The copy of F.I.R dated 20.11.2017 is annexed as Annexure - 7

#### PARA - 10

That, despite several F. I. R lodged against them; they are collecting money with threat from poor persons for Gondwana Gond Mahasabha. Persons are compelled to be member of that Mahasabha else they will face dire consequence. They have to abide the rule made by OP No 4 - 12. The Govt. law is not applicable in their area. They are regulating a parallel govt. which is not only threat to the state itself but also amount to insurgency against the state. They are persuading for a separate State for which Mahasabha is called and fees are being collected.

Copies of receipts showing payment of fees are annexed as Annexure - 8

Out of the allegation made in the petition, the above paras are relating to Akhil Bharatiya Gondwana Gond Mahasaba so far. Before preparation of the defense statement of the case, the accounts in respect of all Palli, Gudi, Punja, Block, Zilla and State are required to be finalized and place it before the chartered accountant for necessary verification and certification. The draft defense statement of the case will be prepared only after receive of final consolidated accounts from district organization.

You are therefore requested to submit your final consolidated accounts in enclosed format by 10/08/2018 in the above address positively so as to prepared defense statement and file before the Hon'ble Court in time.

**MOST RESPECTFULLY SHEWETH**

1. That, petitioner craves indulgence of this Hon'ble court to save his fundamental right, which is breached by Op. No - 4 to 12 deliberately and intentionally by out-casting this petitioner from Gonda Samaj and ostracizing as well as harassing these petitioners by not allowing them to participate in ceremonies of Kulasamaj and prohibiting other persons from attending functions of these petitioner showing their highhandedness. They also prohibiting them from accessing shops, public ghats and public places of the locality as well as from attending public meetings of Kulasamaj, only for the reason that, they are supporting persons who are out-casted by Op.Party No 4 to 12 illegally, and sought for information about proceedings of the Samaj and raise voice against illegal act of self-declared President and Secretary of so called "4500 Ghar Gond Samaj", and Lodging F.I.R against them for extortion made by them to these petitioners and others giving threat of expulsion .
2. That, these petitioners are citizen of India being permanent resident under Loisingha police station which comes under territorial jurisdiction of this Hon'ble court. The cause of action arose within the territorial jurisdiction of this Hon'ble court. Op parties are functionaries of state as well resident under territorial jurisdiction of this Hon'ble court as such both parties are amenable to writ jurisdiction of this Hon'ble court.
3. That sequence of events which leads to file this writ application in short is that, the petitioners are scheduled tribe persons belongs to "Gond" community. The petitioner No - 1 is a retired railway employee, Petitioner No - 2 is a retired Amin and

petitioner No - 3 is a farmer. They have been expelled by the Op No - 4 which is made by some antisocial, ill motivated persons using the registration No of Adima Samaja, without any notice or show cause on the ground that, these petitioners supports some persons who are out-casted by Op No - 4 to 12, sought for information about the details of the Samaj and proceeding of the Samaj, raising voice against self-declared president, secretary of the "4500 Ghar Gond Samaj". These petitioners served with the order of the said Samaj by letter dated 10.04.16.

The copy of the letter dated 10.04.16 is annexed as Annexure - 1.

4. That, it is worthwhile to mention here that, the 4500 Ghara Gond Samaj was never registered at any point of time rather it used the registration number of Adima Samaj having registration no - 5304/410 of 1967-68. The said organization which was made for benefit of Samaj is virtually extinct by unscrupulous persons like Op No - 4 to 12, rather they used the registration number of the said Samaj giving a fake registration number on query it is ascertained that no such number is assigned to any such organization . The Op No - 5 and 6 made such unholy organisation with the help of some antisocial persons to extract money for their benefit and luxury in the guise of welfare of Gond Samaj.

The copy of the registration certificate of Adima Samaj is annexed as Annexure - 2.

5. That, Op No - 4 to 16 virtually running a parallel government collecting tax, fees and inflicting punishment on such non collection, and issuing Caste Certificates and Marriage Certificates to persons belonging to the Gond Samaj and collecting huge money from them for granting such certificate. If anybody not taking such certificate he is out-casted from the Community and harassed by these persons. They have kept their agents in different block and panchayat for granting such certificates and

collecting fees from them. The letter No 194 dated 10.04.16 clearly show above acts of the Op No - 4 to 16.

The Copy letter No 194 dt.10.04.16 is annexed as Annexure - 3.

6. That Op No - 5 and 6 have are using different names of different organisation making them as president and secretary of so called organization. Like on of such organization is Akhila Bharatiya Gondwana Gond Mahasabha. They are making such type of Sabha in order in make themselves unjust enrichment by collecting money from poor persons and spending them lavishly for their own luxury and interest. They had arranged the aforesaid Mahasbha and spread leaflet for the same in different village in the community.

The copy of the Mahasabha held in 23.12.16 to 26.12.16 is annexed as Annexure-4.

That, these petitioners as well as other persons approached commissioner SC & ST requesting to take appropriate action against them who not only infringing fundamental rights of petitioners but also right of other persons and making extortion in the name of Mahasabha having no sanctity at all. They also prohibiting marriage



of members of these petitioners. They are restricting inter caste marriage though govt. persuade for the same for a class less society. So these petitioners prayed for imposing ban on such organization and to take appropriate action against the president and secretary and other members of the said organization.

12. That, there is also paper publication in different daily news papers such as "Samaj", "Dharitri", and "Prameya" about the illegalities and irregularities committed by the Op No - 4 to 12 and collection of huge amount from poor people duping them in various pretext and exploiting them giving threat of expulsion.

The copies of extracts published in newspapers is annexed as Annexure - 10.

13. That, the action of Op. parties are not only oppressive but also harsh one. It affect total adivasi society for which one genuine organization which works for development of the schedule tribe person namely " Adibasi Bikash Samanya Samity" also drawn the attention of the Minister, Scheduled Cast and scheduled tribe about the illegal activities of the Op No - 4 to 12. It is also noted that, when the secretary of the said organization visited to house of poor people of the locality, this fact came into light that they have been duped and extorted by the aforesaid persons. So it was requested for appropriate action against that fraud organization.

The copy of the representation dated.

19.12.17 is annexed as Annexure - 11.

14. That, it is respectfully submitted her that, Op No- 4 to 12 not only extorting the family of the petitioners but also breaching fundamental rights of these petitioners by not allowing them participate in Gond Kula Samaj Meetings and restrict their free will to give marriage to their daughters at their own accord. Right to life include living in a peaceful life without any compulsion and threat from any person whether

belong to Kula Samaj or others. No persons shall be compelled to do anything against his free will which is legal and reasonable one.

15. That, it is respectfully submitted here that, inter cast marriage is not illegal rather it is assured by the state that every person has a right to marry person of his or her choice irrespective of cast, creed and community. In the case of **Lata Singh - Vs - State of Up** the Hon'ble Apex Court reiterated as Follows

"The caste system is a **curse on the nation** and the sooner it is destroyed the better. In fact, it is dividing the **nation at a time when** we have to be united to face the challenges before the nation **unitedly**. **Hence, inter-caste** marriages are in fact in the national interest as they will result in **destroying** the caste system. However, disturbing news are coming from several parts of the country that young men and women who undergo inter-caste marriage, are threatened with violence, or violence is actually committed on them. In our opinion, such acts of violence or threats or harassment are wholly illegal and those who commit them must be severely punished. This is a free and democratic country, and once a person becomes a major he or she can marry whosoever he/she likes. xxxxxxxx We, therefore, direct that the administration/police authorities throughout the country will see to it that if any boy or girl who is a major undergoes inter-caste or inter-religious marriage with a woman or man who is a major, the couple are not harassed by any one nor subjected to threats or acts of violence, and any one who gives such threats or harasses or commits acts of violence either himself or at his instigation, is taken to task by instituting criminal proceedings by the police against such persons and further stern action is taken against such persons as provided by law. We sometimes hear of 'honour' killings of such persons who undergo inter-caste or inter-religious marriage of their own free will. There is nothing honorable in such killings, and in fact they are nothing

but barbaric and shameful acts of murder committed by brutish feudal minded persons who deserve harsh punishment. Only in this way can we stamp out such acts of barbarism”

16. That, it is respectfully submitted here that, act of Op No - 4 to 12 is really barbaric and apprehensive one. As far as human rights are concerned their observance by nation is essential not only for the wellbeing of the human race, but also for its progress and development. It is essential that, his right as an individual as to think, talk and act should be recognized. if freedom of expression , and protection of life and liberty are not guaranteed it would result in harassing uncertainty of life which would at once render human existence meaningless and not the least worthwhile
17. That, it is respectfully submitted here that though these petitioners have approached all authority drawing their attention about the illegal acts committed by the Op No - 4 to 12 but no one venture to restrict them due to their high handedness and political patronage. Rather they collecting money forcible from people and spending the same lavishly without any account. Moreover such organization is a fraud organization which is meant to dupe poor people in the name Mahasabha. They are committing all illegal activities and framing rules which are complete contrary to the rule of the land as well as breach of fundamental rights of persons. The aforesaid organization persuading persons to act against the rule of state and not to obey the law made by the state rather they have to obey the rule made by them. Which clearly show the insurgence against the sovereignty of the state as such the organization of Op No - 4 needs to be banned and members there of needs punishment for their wilful violation of the rule of law.
18. That, finding no other speedy and efficacious alternative remedy available to these petitioners, they ventilated their grievance before this Hon'ble court invoking writ jurisdiction of this Hon'ble court to get proper justice.

PRAYER

It is therefore prayed that, this Hon'ble court may gracious enough to consider the facts stated in the petition, may be pleased to admit this writ application, notice may be issued to Op parties calling upon them to show cause as to why this writ application shall not be allowed, relief prayed shall not be granted if Op parties failed show cause, the writ may be allowed and following relief may be granted.

(i) The decision dated 102.04.16 taken by Op No- 4 vide Annexure - 1 shall not be quashed and action of Op No - 4 to 12 shall be not declared illegal and persons who have taken part in such process of out casting shall not be dealt sternly.

(ii) A direction be made to take appropriate authority to take action against Op No - 4 to 12 who are trying to take away fundamental right of the petitioner without any justified reason.

(iii) A direction may be made preventing Op parties No - 4 to 12 from collecting money from poor people making extortion and adopting unfair means giving threat of expulsion.

(iv) A direction may be made to Op No - 2 and appropriate authority to look into the matter and to take appropriate action who are making anti- social wave in the society and community for their personal benefits causing public dissention and communal violence.

And may issue appropriate direction/directions and may pass appropriate order/orders as this Hon'ble court think just and proper.

And for this act of kindness this petitioner shall ever pray.

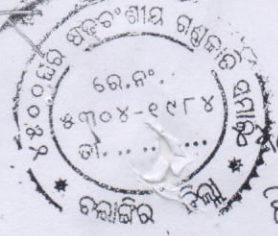


